Seyfarth Shaw Again Ranks as National Leader in 2010 Chambers USA

Clients tell Chambers that Seyfarth is "Extremely customer-focused, with knowledgeable lawyers in virtually every area; most importantly, they understand how to partner with their clients and deliver results."

Chicago, IL (June 14, 2010)—Seyfarth Shaw LLP, one of America's leading full-service law firms, is regarded as among the best law firms in multiple practice areas nationally and in regional markets in the 2010 edition of *Chambers USA*: *America's Leading Lawyers for Business*, and 41 of the firm's attorneys were also individually ranked as leaders in their field.

The firm ranked second in the country in Labor & Employment and Retail, and its ERISA Litigation and Construction Practice Groups each earned third-band rankings in the nation. Practice groups in Seyfarth Shaw's regional offices also earned impressive rankings. The Labor & Employment groups in Chicago and Boston landed in first place in Illinois and Massachusetts, respectively. Further, the Chicago office's Employee Benefits and Compensation practice ranked second in Illinois. Similarly, the Construction Practice Group in Washington, D.C. earned a second-band ranking, as did the Immigration Practice Group in the firm's California offices. The Labor & Employment practice in California was also ranked Band 2. Band 3 honors were earned by the firm's Environmental attorneys and the Real Estate Practice Group in the Chicago office for Illinois; Atlanta's Immigration, Labor & Employment and Real Estate Practice Groups for Georgia; and New York and Washington, D.C.'s Labor & Employment practices.

Forty-one of Seyfarth Shaw's attorneys throughout the nation were singled out as leaders in their field of law. In California, seven attorneys were recognized (Labor & Employment and Immigration); Georgia had eight (Construction, Immigration, Labor & Employment, Litigation and Real Estate); the firm's Chicago office saw 14 attorneys make the list (Employee Benefits & Compensation, Environment, Labor & Employment and Real Estate); *Chambers* ranked four attorneys in the Boston, Massachusetts office (Labor & Employment and Employee Benefits & Executive Compensation); three attorneys in the New York office were ranked (Employee Benefits & Executive Compensation, Labor & Employment, and Real Estate); and the firm's Washington, D.C. office is home to five of the firm's attorneys ranked by *Chambers* (Construction, Labor & Employment and Real Estate).

Practice Group Rankings

#2 National Ranking in Labor & Employment

Clients told *Chambers*, "Its lawyers work hand in hand with their clients, offering a seamless service across the country." According to the guide, "This firm is headquartered in Chicago and is particularly strong in the Midwest; however, its substantial network of offices from coast to coast ensures that it maintains a strong national reputation as well.... #2 National Ranking in Retail

Recently, this has included successfully settling a dispute for Talbots with one of its Hong Kong-based vendors relating to the schedule for and completion of millions of dollars of purchase orders for the manufacture of a clothing inventory."

#3 National Ranking in Construction

Sources told *Chambers*, "This firm's spread of offices throughout the USA is extremely advantageous for clients; it has great resources and goes above and beyond the call of duty for its clients." The guide noted, "This group combines contentious and non-contentious expertise, offering clients an impressive depth of representation. It covers contracts, teaming agreements, project management and a range of disputes. It also regularly assists clients with infrastructure projects on a global basis, and PPP work is a forte.
