



## **IMMIGRATION ALERT!**



### **SPECIAL REGISTRATION DEADLINES FOR CERTAIN FOREIGN NATIONALS**

The Immigration and Naturalization Service (INS) now requires that certain foreign nationals already present in the United States appear before an INS officer to undergo special registration procedures; depending on nationality of the foreign national, the registration deadline is either **December 16, 2002** or **January 10, 2003**.

#### ***Who Must Register***

Any male born on or before November 15, 1986 and who is a national (i.e., born in) or citizen of Iran, Iraq, Libya, Sudan, or Syria must register with the INS by **December 16, 2002** if **ALL** of the following apply:

- currently in any immigration status EXCEPT that of A or G nonimmigrant, lawful permanent resident (green card), asylee, or applicant for asylum (application made on or before November 6, 2002)
- most recent admission to the U.S. was on or before September 10, 2002
- will remain in U.S. until December 16, 2002 or beyond

In addition, any male born on or before December 2, 1986 and who is a national (i.e., born in) or citizen of Afghanistan, Algeria, Bahrain, Eritrea, Lebanon, Morocco, North Korea, Oman, Qatar, Somalia, Tunisia, United Arab Emirates, or Yemen must register with the INS by **January 10, 2003** if **ALL** of the following apply:

- currently in any immigration status EXCEPT that of A or G nonimmigrant, lawful permanent resident (green card), asylee, or applicant for asylum (application made on or before November 22, 2002)
- most recent admission to the U.S. was on or before September 30, 2002
- will remain in U.S. until January 10, 2003 or beyond

It does not appear that dual nationality or citizenship affects the registration requirement.

## ***Registration Process***

Those who must register are required to appear at a designated INS office before an INS officer to complete the registration process, which will include, among other things, an interview under oath, fingerprinting, photographing, and the presentation of acceptable proof of status and residence (see *Required Documents*). Note that registration is an annual process: Any person who registered is required to reregister in every subsequent year within 10 days of the original registration date.

## ***Required Documents***

To comply with the proof of status and residence requirements, the following documents should be taken to the registration interview:

- passport (or any other repatriation/travel documents held if no passport)
- Form I-94 or I-94W issued upon last admission to U.S.
- any other government issued form(s) of identification
- if living in the US: land title, mortgage documents, or rental/lease agreement
- if visiting the US: statement from host, hotel address/bill, company housing info, or other accommodations details
- proof of employment (especially if status is employment based)
- proof of matriculation and good-standing at educational institution (especially if status is school-sponsored)
- any other related documents felt to be helpful, relevant, or necessary to confirm or clarify residency or status
