Seyfarth Shaw Earns Top National and Regional Marks in Latest U.S. News/Best Lawyers Law Firm Rankings

Peer-based survey ranks four Seyfarth practice areas in first tier nationwide, and another six on top of metro area rankings; total of 57 Seyfarth practice areas finish in tiers one, two, or three nationally and in eight metro areas coast to coast

The *U.S. News/Best Lawyers* "Best Law Firms" ranking is based on evaluations provided by peer lawyers and clients, making it a substantive analysis of law firms by those best positioned to assess them objectively. More than 9,600 law firms were graded for the 2011-12 rankings, which also incorporate 3.9 million evaluations of more than 41,200 leading individual attorneys.

The four Seyfarth practice areas ranked in the *U.S. News*/Best Lawyers first tier nationally are Employment Law – Management, Labor Law – Management, Litigation – Construction, and Litigation – Labor & Employment—a reflection of Seyfarth's traditional strength in labor and employment matters. The firm's nationwide rankings in the second tier demonstrate Seyfarth's capacity in other areas of the law, as the firm was noted for its performance in Construction Law, Corporate Law, Environmental Law, Immigration Law, and Litigation – Environmental.
