REVISED FORM AR-11 AND NEW FORM AR-11 SR

The Immigration and Naturalization Service (INS) requires that foreign nationals provide notice in writing within 10 days of a change in residence address. Most foreign nationals will notify the INS of the address change through the filing of Form AR-11; certain foreign nationals (as discussed below) are required to use a different change of address form, Form AR-11 SR. Form AR-11 itself has not changed, but the addresses to which the form is required to be sent has in fact changed. Following are the new addresses for Form AR-11:

The INS requires that certain foreign nationals use a different form to notify of any change in address, Form AR-11 SR. **Form AR-11 SR must be used by any foreign nationals who are subject to the special registration requirements recently implemented by INS. Currently, foreign nationals required to use Form AR-11 SR include nonimmigrants who are nationals of Iran, Iraq, Libya, Sudan, and Syria in addition to any other nonimmigrants subject to special registration.** Form AR-11 SR is identical to Form AR-11 except that it requests the

Fingerprint Identification Number that would have been assigned during the special registration process; further, although Form AR-11 SR is sent to the same address as Form AR-11, the mailing address must reflect the “special registration” status, as follows:
