Minimum Annual Salary	Required salary for managers and directors is currently € 54, 142 per year. For professionals and specialists, it is € 40,077 per year. A reduction coefficient of 0.75 points may be applied to small companies in strategic sectors and to high- qualified employees under the age of 30.	Required salary is at least 1.5 x the average gross annual salary for the specific job to be performed.	Salary should correspond to what a resident worker could expect to receive for the same position. Salary must be indicated in local currency and in Euros. Collective Bargaining Agreements and any remuneration in kind must also be included. Remuneration in kind must not exceed 30% of the total remuneration package. Main applicants must prove their monthly earnings are 100% IPREM (Spanish Earnings indicator or (<i>Indicador Público de Renta de Efectos Múltiples</i>) and additional 50% IPREM per dependent.	Salary must correspond to what a local resident worker would expect to receive for working in the same position.
