



Immigration Landscape - Where and Why of Current State




Immigration Landscape

Where & Why of Current State

- Congress has been gridlocked on immigration matters for decades
- Demand for H-1Bs and has grown in last 10+ years
- Path for F-1 students to transition to H-1B has been fraught with pitfalls
- Organized labor remains suspicious of employmentbased immigration
- Concerns about fraud continue within USCIS and elsewhere
- Registration system was abused by certain individuals and companies
- Trump NPRM Enjoined in Federal District Court leading to where we are now

What Does It Say & What Does It Mean -H-1B Modernization Proposed Rule







Number of H-1B Cap registrations submitted in March 2023. 110,791 Selected ~14% selection rate

Highlights

H-1B CAP – Registration & Lottery

- Registration Integrity
 - One person = One entry. Regardless of how many companies submit the person.
 - One company = One registration. Related entities may not submit the same person multiple times.
- Broader Implications
 - Return to pre-registration numbers?



Highlights

H-1B CAP – Registration & Lottery

- F-1 Students and cap-gap work authorization extended to April 1
- H-1B start date flexibility codified
- Cap-exempt H-1B employer expansion.
 - "fundamental activity" does not have to be the "primary mission."
- Broader implications
 - May need to train I-9 team to handle new cap-gap period
 - Potential for collaboration with research centers for capexempt status

Highlights

H-1B Definitions & Clarifications

- More than one degree may qualify
 - "A position may allow a range of degrees or apply multiple bodies of highly specialized knowledge"
- Clarifying the definition of "**normally**" requiring a bachelor's degree for entry into an occupation
 - usual, typical, common, or routine
 - normally does not mean always
- Broader implications
 - What does this mean for your H-1B sponsorships and options?

Highlights

Codifying the Status Quo & Simeio

- Amendment will continue to be required for new worksites outside of area of intended employment.
- Deference to prior approvals if no material changes and same facts.
- Expressly empowers USCIS officers to ensure LCA corresponds with the H-1B petition.
- Broader implications
 - Possible increase in USCIS site visits

H-1B Definitions & Clarifications


- Re-defining "specialty occupation"
 - Treatment of positions with "general" degrees.
- Broader implications
 - Impact on talent pool for companies and incoming international students for Universities
 - Industries and Occupations impacted with broad generalization
 - Industries: Consulting, Finance
 - Occupations/Degrees: MBAs, General Engineering, Marketing, Liberal Arts

Highlights

H-1B Definitions & Clarifications

- Directly related specific specialty
- Third party placement what does the "end client" normally require?
 - Actual work to be performed at end client must be in a specialty occupation.
- Broader implications
 - Site visits changes what it means for an end client
 - Possible interplay with joint-employer liability where the client should NOT be setting any conditions of the employment
 - Penalties for non-compliance include denial and revocation of petitions.




Administration Initiative – Al Executive Order

Interplay of the EO & H-1B Modernization Proposed rule

- Is the proposed rule "Clarifying & Modernizing Pathways"?
- Some portions seems at odds with the intent of the EO
 - AI and emerging technologies sector crosses traditional academic boundaries
- DHS is tasked with reviewing and initiating necessary policy changes designed to continue the process of modernizing the H-1B program
 - What should this look like?
